Open Minds Campus – 2022 Fees

Payment options

There are *three payment options* offered, being *annual*, *termly*, and *monthly* for the 2022 academic year. The monthly option allows parents to pay fees over a 12-month period. The fees equate to a *10% discount* and a *5% discount* on the yearly and termly fees, respectively.

Fees are payable based on the payment plan selected. The payment plan selected should be maintained throughout the course of the academic year.

- Annual plan: payable before 10 January 2022
- Termly plan: payable no later than the first day of each term
- Monthly plan: payable in advance by the seventh day of each month.

Only EFT payments will be accepted. All associated bank charges will be levied onto the account (such as cash deposits and card payments fees).

All payments should have a reference: *Child name and surname*

Late payments: Payments made after their respective deadlines will incur a R200 administration cost, and will be added to the account. Annual and termly payments made after the deadline will result in the discount being forfeited.

Levies

Deposit (non refundable): A once of R7500 enrolment deposit that includes registration fees is payable.

Stationary: This is not included. A stationery list will be provided and parents will need to procure these items themselves from their preferred supplier.

Cambridge Assessment: Examination fees will be paid directly to the exam centre.

There may be an additional charge for textbooks/workbooks issued to the learners.

Family discount

The school offers a discount for families. The discount applies to the fees from the second child onwards. The discount excludes the enrolment deposit and ancillary charges.

The sibling discount offered is as follows:

Child #1: 0% discount

Child #2 onwards: 5% discount

The discount amount will be taken from the fees of the younger sibling.

Referral Discount

We offer all current Open Minds families a discount of R2000 (on their own child's fees) for each new student referral. This discount will only apply:

- if the new student referred is successfully admitted to the school
- the current parent is referenced on the new student's application form
- after the new student's full deposit and first month of fees have been paid.

This referral discount is only applicable in the year of referral. Only one referral discount can apply per new student enrolled.

Pupils are accepted into the School when:

- Parents have had an interview with the Administrator and/or Facilitator/s.
- The child spends five (5) days in the School's environment for observation and assessment, and a parental feedback session has been held.
- Parents have paid the non-refundable enrolment deposit (R7 500) in full.

Notice

Should you withdraw your child from Open Minds Campus for any reason whatsoever, you have undertaken to give one (1) full calendar month notice of such withdrawal, in writing, to the school office. Notice however cannot be given during December for the following year. No fee payments will be refunded should you wish to give notice for a date earlier than has already been paid (such as for annual and termly plans).

Responsibility of parent/s or Guardian

The onus is on the Parent to monitor their accounts. If the Parent is unable to honour payments for whatever reason, it is the responsibility of the Parent to contact the School so that the situation can be reviewed. Any outstanding payments beyond one (1) month in arrears will lead to the child not being able to attend the school until the account has been settled.

Consent

1. Parents consent that, by enrolling a child at Open Minds Campus (OMC), OMC is at all times able to contact, request and obtain information from any credit or service provider (or potential credit or service provider) or registered credit bureau relevant to an assessment of the behaviour, profile, payment patterns, indebtedness, whereabouts, and creditworthiness of the parent;
2. Parents also authorise OMC to at all times, furnish information concerning the behaviour, profile, payment patterns, indebtedness, whereabouts, and creditworthiness of the parent to any registered credit bureau or to any credit or service provider (or potential credit or service provider) seeking a reference regarding the parent's dealings with the school.
