Payment options

There are three payment options for the 2025 academic year: annual, termly, and monthly. The monthly plan allows parents to spread payments over a 12-month period. Annual payments receive a 10% discount, while termly payments receive a 5% discount.

Fees are payable according to the selected plan and should remain consistent throughout the academic year.

- Annual Plan: Payment due by 10 January 2025
- Termly Plan: Payment due on the first day of each term
- Monthly Plan: Payment due in advance by the 7th of each month

We recommend EFT payments. Please note that any bank charges (e.g., cash deposit or card payment fees) will be added to your account.

All payments must reference the child's name and surname.

Late Payments

Payments received after the due date will incur an administrative fee of R200, which will be added to your account. Additionally, late annual or termly payments will result in the forfeiture of any discounts.

Registration Fees

A non-refundable registration fee of R2,500 is payable upon enrollment. This is a once-off fee.

Stationery

Stationery is not included in campus fees and will be charged separately. An additional fee covering the required stationery for the year will be billed at the start of the year. Stationery will be distributed at the beginning of the academic year, and parents will be responsible for replenishing items as needed

For students enrolling in the final term, a stationery list and prorated fee will be provided.

Cultural Activity Fees

Additional charges may apply for participation in cultural activities such as debate, public speaking, and provincial or national events. These fees cover entry and related costs and will be communicated to parents in advance.

Cambridge Assessment

Examination fees for Cambridge assessments must be paid directly to the exam centre.

Books and resources

Textbooks and workbooks will be billed separately as they are supplied.

Sibling discount

We offer sibling discounts as follows:

First child: No discount

• Second child: 10% discount on both children's fees

• Third child and beyond: 20% discount on all siblings' fees

This discount excludes the enrolment deposit and any additional charges.

Referral Discount

Current Open Minds families are eligible for a R2,000 discount on their child's fees for each successful referral of a new student. This discount is subject to the following conditions:

- The referred student must be successfully admitted to the campus.
- The current parent must be named as the referral on the new student's application.
- The new student's registration fee and first month's fees must be fully paid.

The referral discount is valid only in the year of referral, and only one discount applies per new student.

Admission Criteria

A child is accepted into the campus when:

- The parents have had an interview with the Administrator and/or Facilitator.
- The child has been assessed in our environment, followed by a feedback session with the parents.
- The non-refundable registration fee of R2,500 has been paid in full.

Withdrawal Notice

Should you wish to withdraw your child from Open Minds Campus, you must provide one full calendar month's written notice. Please note that notice cannot be given in December for the following year. No refunds will be issued for fees already paid under annual or termly plans.

Parent/s or Guardian responsibility

It is the responsibility of the parent/guardian to monitor their account. If you are unable to make payments on time, you must inform the Administration Office for a review of your situation. Accounts that are more than one month in arrears will result in the child being unable to attend the campus until the account is settled.

Consent

By enrolling a child at Open Minds Campus, parents/guardians consent to:

- Open Minds Campus contacting and obtaining information from any credit or service provider or registered credit bureau regarding the parent's credit profile, payment patterns, and creditworthiness.
- Open Minds Campus furnishing relevant information about the parent's credit profile and payment history to any registered credit bureau or credit/service provider requesting a reference.
